At the first outset Secretary General welcome all office bearers/ delegates and requested for their self introduction.

The business commenced as per agenda circulated by the President as below.

1. Confirmation of minutes of last meeting

Secretary General read out the minutes of last meeting held at Dutta Bhavan Delhi on 17/18 Aug. 2013. The minutes were confirmed unanimously in the meeting.

2. Brief Report on the organizational activities.

Secretary General has submitted his up to date report on the organizational activities since the last meeting.

- (i) He highlighted the progress on registration of Forum issue. The proposal was immediately submitted to the Dy. Commissioner which was forwarded by his office to the Min of Food and Consumers Affairs in Oct. 2013 for clearance of the name under S.R. Act 1860. The said ministry was reminded severally on phone as well as lodging grievances however it is still pending. Hon. Jual Oramji, Union Minister, has kindly agreed to intervene in the matter and it is hoped that the matter will be solved in short period.
- (ii) He informed the house regarding the affiliation to the Bharat Pensioner Samaj, Coordination with the J.C.M.(Staff Side) and allied matters. Er. S.S Dubey has been selected on the Managing Committee of the B.P.S as well as Chairman of the Committee for Co Ordination of various associations for 7th C.P.C.in J.C.M He expressed his thanks to the above two organizations. House unanimously congratulated Er. S.S Dubey for this new assignments.
- (iii) He also informed and detailed every demand put forth in the Memorandum submitted to 7th C.P.C. by the Forum as well as the memorandum by A.I.F.O.D.E. He informed the house that request for oral Interview by the C.P.C is already made and there is no further development noted in C.P.C. The soft copy was already sent to units on e mail however Er. P.S.Grewal and other requested to issue hard copies also. The Secy. Gen. has expressed the financial crunch and requested the interested persons to get it photocopied there. As the Secretary General A.I.F.O.D.E. publically narrated, and thanked for the contribution of the office bearers of Forum

in preparing the Memorandum of A.I.F.O.D.E., the house has appreciated the efforts of the office bearers in this regards.

3. The Secy. Gen. informed that permission to construct our own Separate Building of the Forum in Datta Bhavan Delhi premises was kindly approved by the A.I.F.O.D.E. in it's E.C. Meeting of 1st Nov 2014. House welcomed the decision by huge clapping and special thanks were given to all office bearers and Executive Committee of A.I.F.O.D.E. He solicited the generous donations and contribution for the construction of the building. Er. J.S.Jaggi (Z.S A.I.F.O.D.E.Jammu) has hannounced his personal donation of Rs. 50 thousands and Er. Bindu Bhushan Singh has announced the contribution of Rs. 25 thousands on behalf of Barabanki zonal unit. (U.P) These donations were highly welcome in the applause and the doners were thanked by the house.

4. Financial Status

Hon President on behalf of the Finance Secretary highlighted the financial status. The meager contribution was received initially which was exhausted towards expenses of Registration, web site and other. There after except Tamil Nadu no affiliation or other corpus fund amount is received. As the registration is still pending, the receipt books, letter pads etc are not printed so far. We in spite of incurring personal expenditure, carrying out the work in Delhi etc and as such the state units are to come forward without waiting for further requests. He appealed to deposit the stipulated contribution soonest possible. Secy. Gen. has informed that none of the Office bearer has claimed any T.A. Bill so far. In response to the appeals of the President and Secy. Gen. the fallowing office bearers have announced their contribution and handed over the amount.

5. Organizational activities of State Units and suggestions for improving the working.
